No person shall be eligible to contest elections on two seats simultaneously. The candidate, proposer and seconder shall not be defaulter. A member shall not be eligible to contest the elections if he has not completed minimum period of one year from the date of acquiring membership in the Society to the date of filing of the nomination.

**NOTE :**

1. As per provisions in the DCS Act and Rules, the defaulting members are not eligible to contest the elections, but they are entitled to cast their votes except those members against whom decree has been issued under section 61. nomination was displayed on the notice board of Returning Office at 5.30 p.m. on race. Therefore, final list of contesting was also displayed on the Notice Board of the Returning


Officer as well as on is hereby further informed that only 12 (Twelve) Nominations were received for any posts for which election is scheduled.
