A member shall not be eligible to contest the election, if he/she has not completed minimum period of one year from the date of acquiring membership in the society to the date of filing of the nomination.

Interested member can obtain the membership list from the society office against payment of prescribed fees, as per provisions of DCS Rules 2007.


**SPECIAL NOTE**


The counting, if required will commence immediately after the polling is over and result will be declared immediately on completion of the counting procedure.

**NOTE**

1. As per provisions in the DCS Act 2003 & DCS Rules, 2007, the defaulter members are neither eligible to contest the election not entitled to cast their votes. However, in case, if they make the payment of their dues **before the date of filing of nomination to the society** and produce the proof thereof before the undersigned, they will not be treated as defaulters and shall be allowed to contest the election as well cast the votes. 
