In case the candidate gets less than 1/6th of the total votes polled, the security deposit shall be forfeited and such candidate shall be disqualified from contesting the elections in this Society for a period of two terms of committee. No person shall be eligible to contest elections on two seats simultaneously. The candidate, proposer and seconder shall not be defaulter. A member shall not be eligible to contest the elections if he has not completed minimum period of one year from the date of acquiring membership in the Society to the date of filing of the nomination.

The list of members alongwith the list of Defaulting members of the aforesaid Society shall be displayed at the office of the undersigned and the notice board of the Society for information of the members. Interested members can obtain the membership list from the Society office against payment of prescribed fee, as per provisions of DCS Rules, 2007.

**NOTE :**

1. As per provisions in the DCS Act 2003 & DCS Rules, 2007, the defaulter members are neither eligible to contest the election not entitled to cast their votes.
